PRESS RELEASE – January 29, 2013:

1. **WAYWARD Juvenile - Disorderly Conduct:** On January 22nd, 2013 at 1:30 PM, School Resource Officer Anthony Zoglio arrested a **15-year-old male student** at Chariho High School on a charge of **Disorderly Conduct** after he struck another male student in the face numerous times during a confrontation that occurred in a hallway. Staff members interrupted the altercation immediately after it was observed. The student shall be referred to Family Court on the above charge.
2. **Misdemeanor - Motor Vehicle and DUI (BAC .10-.15):** On January 22, 2013 at 6:00 PM, Patrolmen Daniel Kelley arrested **Lori Closterman**, age 50, of 31 Buttonwoods Rd., Richmond, on a charge of **Driving Under the Influence of Alcohol - 1st Offense**, after a 911 call reported an erratic driver on Main St. Ms. Closterman was processed at the station, where she subsequently submitted to a Breathalyzer test that resulted in BAC (blood-alcohol-content) readings of **.222 (1st phase)** and **.211 (2nd phase)**. Ms. Closterman was released with a summons to appear for arraignment in 4th District Court on the above charge.
3. **Misdemeanor -DUI (BAC unknown) & Refusal to submit Chemical Test:** On January 25th, 2013 at approximately 2:30 AM, Corporal William Litterio, arrested **Ryan Croce**, age 21, of 7 Meadowlark Terrace, Richmond, on charges of (1) **Driving Under the Influence of Alcohol - 1st Offense (BAC unknown)**, (2) **Refusal to submit to a Chemical Test**, (3) **Failure to maintain Proper Control MV**, after being dispatched to West Shannock Rd for a report of a motor vehicle crash. Mr. Croce was transported to the station where he was processed and released with a summons to appear for arraignment in 4th District Court on the above criminal charges.
4. **Misdemeanor - Reckless Driving:** On January 25th, 2013 at approximately 2:30 AM, Patrolman Jeffrey Vaughn arrested **Alexander M. Hennessy**, age 19, of 7 Karen St, West Babylon, NY, on a charge of **Reckless Driving**. Officer Vaughn was dispatched for an erratic driver on Kingstown Rd. The vehicle was observed driving recklessly at the Stilson and Kingstown Rd. area. Officer Vaughn eventually pulled over Mr. Hennessy on Rte 95. Mr. Hennessy was transported to the station for processing, and released with a summons to appear in 4th District Court on February 28th, 2013.
