## PRESS RELEASE – July 2<sup>nd</sup>, 2013:

- Misdemeanor - Domestic Malicious Damage, Disorderly Conduct, and Vandalism :** On June 26, 2013, at approximately midnight, Patrolmen Jeff Vaughn and Daniel Kelley arrested **Ryan Freelove**, age 34, of Hillsdale Park, 465 Gardner Road, Richmond on charges of (1) *Domestic - Malicious Damage*, (2) *Domestic - Disorderly Conduct*, and (3) *Vandalism (holding cell)*, after a 9-1-1 call caused officers to be dispatched to the above address where Mr. Freelove had forced entry into the residence by smashing the glass out of the storm door, and the glass panels of the main entry door. He was returned to the station and held overnight for arraignment. While in custody, Mr. Freelove engaged in disorderly behavior and caused deliberate damage to the drop ceiling tile(s) of the holding cell. Mr. Freelove was processed and transported to 4<sup>th</sup> District Court where he was arraigned on the above charges, and was released on personal recognizance with a *No-Contact Order*.
- Misdemeanor - Motor Vehicle:** On June 26<sup>th</sup>, 2013 at approximately 9:00 PM, Corporal William Litterio and Officer Jeffrey Vaughn arrested **Leslie Parent**, age 50, of 269B Nooseneck Hill Rd, Wyoming, on a charge of *Operating with a Suspended License*, after a motor vehicle stop on Nooseneck Hill Road revealed that her license had been suspended for *Failure to Appear/Pay Fines*. Ms. Parent was transported to the station, processed, and released with a summons to appear for arraignment in District Court on the above charge.
- Misdemeanor - Domestic Simple Assault and Domestic Disorderly Conduct:** On June 27<sup>th</sup>, 2013 at approximately 9:45 PM, Patrolmen Daniel Kelley and Steven Gravier arrested **Robert Rawson**, age 67, of 3 Fairside Drive, Carolina, on charges of (1) *Domestic Simple Assault/Battery* and (2) *Domestic Disorderly Conduct* after officers were dispatched to the above address for a 911 hang-up. Officers conducted an investigation at the scene, and arrested Mr. Rawson on the above charges. He was returned to the station where he was processed, and subsequently arraigned before a Justice-of-the-Peace. He was released on personal recognizance, and was issued a *No-Contact Order* barring him from contact with the victim.

4. **Misdemeanor - Motor Vehicle:** On June 28<sup>th</sup>, 2013 at approximately 6:30 PM, Officer Anthony Zoglio arrested **Matthew A. Eva**, age 22, of 113 Kuehn Road, Hopkinton, on a charge of *Operating with a Suspended License*, after a motor vehicle stop in Richmond revealed that his license had been suspended for *Failure to Appear/Pay Fines*. Mr. Eva was transported to the station, processed, and was released with a summons to appear for arraignment in 4<sup>th</sup> District Court on the above charge.
